This stage focuses on deeper stress identification and support, including the use of more technically focused screens. These levels are not about navigation (you will be expected to spend the time necessary to be a little familiar with the navigation steps) and are about integrating the major device facilities into clinical stress reduction.

Completion of stage 3 training, on line exams, observed operation for safe and appropriate use, submission of advanced case studies enable the issuance of an IMUNE International License Quantum Biofeedback Therapist confirmed on submission of proof of 6 months clinical practice.

After stage 2 the student will have an increased range of facilities and deeper understanding of the application of advanced biofeedback enabling them to start working with deeper seated and more specific stress issues.

Course Elements

1. Technical- program use (students should ensure familiarity with all the navigation of all listed screens prior to this level)
2. Classroom demonstration- to set a context for deeper client dialogue.
3. Case studies- using common classroom subject.
4. Case studies- from student clinical experience
5. Education exams- student learning review (score does not form part of assessment)
6. On line exams- covering the main aspects. Pass mark 85%, distinction 95%.
7. Practice education handouts preparation.

Level 2 &3 Preparation

The following is suggested.

1. Complete (well!) the level 1 case studies.
2. Have done minimum 10 sessions



3. Read the material marked * below
4. Have practiced navigation of the topic screens.

Level 2 &3- (Intermediate/Advanced)- Topics

The topics are segregated into level 2 and 3 for information only- the order is at educator's discretion. The aim is proficiency in the next layer of stress assessment (specific issues) and to broaden the range of stress reduction options. Some screens are interesting) e.g. biface but require only a navigational skill and can be adequately covered by the student working alone.

Key- L2= level 2 (Intermediate), L3= level 3 (advanced), * = navigation familiarity required before class, + = home study adequate.

Class Observation Session

This is to ensure that the student applies the assessment and therapy aspects appropriately for assessing:

1. General stressors
2. Disturbed areas
3. If there are or are not specific stressors for the client.

It is suggested that there are two (2) class observed sessions in which students work according to a guide format

<u>Case 1</u>	Specific stress condition (in a specific functional area e.g. diabetes, cardiovascular, cancer)
<u>Case 2</u>	A specific causal stressor (e.g. DDT)

The students are recommended to also do a live session on a class mate.

All 3 can be submitted as part of the therapist case study submissions.

Therapist Case Study Submission Forms

There are 5 case studies required in total

1. In class (3 studies)
 - a. Using a live class common subject
 - b. 1:1 working sessions in class
2. External client sessions- 2 clients, 3 sessions each. Submissions should include information scheduled on the worksheet, printout (highlighted/annotated) but may be in therapist's standard working format. Each session should include no more that 2 pages (plus support information)

Practice Education Handouts

This exercise is practical- ensuring that you have the knowledge to talk to clients and educational information for them to consider.

- The effects of absent organs- effects and compensations available.
- Digestion as a fundamental for wellness.
- Synthetic drugs
- Steroids
- Metallic fillings and composites
- Sugar- types, processing routes, nutrient robbing, blood sugar hormonal effects, alternatives (some as neurotoxic)
- Toxicity-effects of X rays, CAT Scans, MRI etc., chemical exposure (many compounds that the body can't process), low level urban exposure
- Trauma- body storage of unresolved issues, effect of structure on function etc.



- Infections- role of immune system and effects if not treated naturally.
- Weight and size management
